PARTICIPANT ACKNOWLEDGMENT, GENERAL RELEASE and INDEMNITY

ESPN NATIONAL GOLF CHALLENGE

I have completed and submitted an entry form (the "Entry Form") to participate in the ESPN National Golf Challenge which, for purposes hereof, includes any qualifying rounds and play-offs at any local or regional qualifying Host Site and, if applicable, the National Finals, together with all related appearances, activities and events (all, collectively, the "Golf Challenge"). In signing the Entry Form, I agree to be bound by all of the terms of this Participant Acknowledgment, General Release and Indemnity (the "Release"). In consideration of being permitted to participate in the Golf Challenge, and for other good and valuable consideration, which I have received, I hereby acknowledge and irrevocably agree to the following terms and conditions, which shall govern my participation in the Golf Challenge:

1. I hereby represent and warrant that I meet all eligibility requirements to participate in the Golf Challenge under the Rules and Regulations and that I have accurately and truthfully completed the Entry Form and all other documents in connection with my participation.
2. I understand that participation in the Golf Challenge requires physical and mental exertion and may present the risk of physical or mental harm or injury, whether through such exertion or due to accidents or events caused by or involving parties other than myself or otherwise.
3. I represent that I have never been convicted of any felony and that I am not subject to any outstanding arrest warrants.
4. I understand that ESPN Productions, Inc., the applicable Host Site or Host Site Pro will make all determinations with respect to the Golf Challenge and may, in any of their individual sole discretion interpret, modify or amend the Rules and Regulations, suspend or terminate play (whether of a particular round, at a particular Host Site, with respect to the entire Golf Challenge, or otherwise) at any time and for any reason including but not limited to safety or health of participants, weather, acts of God, law or local ordinance, strike, war or other conflict, time of day, site availability, mechanical failure, technical malfunction, or for no reason at all. I agree that all determinations made by ESPN Productions, Inc., the applicable Host Site or Host Site Pro will be made in such party's sole discretion and will be final and not subject to appeal of any kind.
5. I understand and agree to abide by all additional rules and guidelines concerning the Golf Challenge not contained in the Rules and Regulations, as presented to me at any time during the Golf Challenge, whether by ESPN Productions, Inc., the applicable Host Site or Host Site Pro, and that such rules and guidelines may change at any time, for any reason or for no reason at all. I understand and agree that ESPN Productions, Inc., the applicable Host Site or Host Site Pro may disqualify me from the Golf Challenge if I am found to have violated any such rules and guidelines, that any such decision shall be made in the deciding party's respective discretion, and that any such decision is final and not subject to appeal of any kind.
6. I understand and agree that I may be penalized, up to and including disqualification from the Golf Challenge at any time if I fail to abide by the Rules and Regulations, or have misrepresented anything herein or in the Entry Form or other relevant documents, or if ESPN Productions, Inc., the applicable Host Site or Host Site Pro, in its or his respective sole discretion, believe that I have acted in an unsportsmanlike manner, have cheated in connection with the Golf Challenge, or that my continued participation in the Golf Challenge could be disruptive and/or pose a danger or threat to others or myself. I further agree that any of ESPN Productions, Inc., the applicable Host Site or Host Site Pro shall have the right, in its or his respective sole discretion, to remove me from the Golf Challenge or modify my handicap at any time for any other reason not specified herein, or no reason. I acknowledge and agree that my removal or disqualification from the Golf Challenge will not void or otherwise affect any of the releases, waivers and other agreements contained in this Release or any of the other documents or instruments that I executed or agreed to be bound by in connection with my participation in the Golf Event.
7. I ACKNOWLEDGE THAT MY PARTICIPATION IN THE GOLF CHALLENGE MAY PRESENT CERTAIN RISKS TO ME, AND I HEREBY ASSUME ANY AND ALL RISKS ASSOCIATED WITH MY PARTICIPATION IN THE GOLF CHALLENGE, INCLUDING, BUT NOT LIMITED TO, THE RISK OF DEATH OR PHYSICAL OR EMOTIONAL INJURY, MINOR AND/OR SEVERE BODILY HARM, AND/OR ILLNESS, AND/OR PROPERTY DAMAGE WHICH ARISE BY ANY MEANS, INCLUDING BUT NOT LIMITED TO: INSTRUCTION BY ESPN PRODUCTIONS, INC. OR ANY HOST SITE OR HOST SITE PRO; ACTS, OMISSIONS, RECOMMENDATIONS OR ADVICE GIVEN BY ESPN PRODUCTIONS, INC. OR ANY HOST SITE OR HOST SITE PRO OR ANY OF THEIR

RESPECTIVE AGENTS, EMPLOYEES, OR OTHER PERSONS OR ENTITIES AFFILIATED WITH THE GOLF CHALLENGE; LATENT OR APPARENT DEFECTS OR CONDITIONS IN ANY EQUIPMENT USED IN OR IN CONNECTION WITH THE GOLF CHALLENGE; THE USE OR OPERATION BY ME OR OTHERS OF SAID EQUIPMENT; ACTS OR OMISSIONS OF OTHER PEOPLE; WEATHER OR OTHER NATURAL CONDITIONS; MY OWN PHYSICAL CONDITION; MY OWN ACTS OR OMISSIONS; FIRST-AID, EMERGENCY TREATMENT OR OTHER SERVICES RENDERED TO ME OR OTHERS. I HEREBY AGREE TO VOLUNTARILY ACCEPT AND ASSUME ANY AND ALL SUCH RISKS AS WELL AS ANY RISKS NOT MENTIONED HEREIN (THE FOREGOING EXAMPLES NOT PURPORTING TO BE A COMPLETE OR EXHAUSTIVE LIST) THAT ARE ASSOCIATED WITH MY PARTICIPATION IN THE GOLF CHALLENGE.

8. I AND MY HEIRS, EXECUTORS, ADMINISTRATORS AND ASSIGNS HEREBY VOLUNTARILY AND KNOWINGLY, RELEASE, DISCHARGE AND RELINQUISH ANY AND ALL CLAIMS, ACTIONS AND LAWSUITS OF ANY KIND AGAINST ESPN PRODUCTIONS, INC., ANY HOST SITE, ANY HOST SITE PRO AND, AS APPLICABLE, EACH OF THEIR RESPECTIVE PARENT, SUBSIDIARY AND AFFILIATED COMPANIES, AS WELL AS ALL EXISTING AND FORMER OFFICERS, DIRECTORS, AGENTS, EMPLOYEES, REPRESENTATIVES, LICENSEES AND ASSIGNS OF EACH OF THE FOREGOING, RELATED TO OR ARISING FROM MY PARTICIPATION IN THE GOLF CHALLENGE, INCLUDING, WITHOUT LIMITATION, ANY CLAIMS, ACTIONS OR LAWSUITS FOR WRONGFUL DEATH, NEGLIGENCE AND/OR OTHER FAULT, EITHER ACTIVE OR PASSIVE, PERSONAL INJURY, DEFAMATION, FALSE LIGHT, RIGHT OF PUBLICITY, INVASION OF PRIVACY, FRAUD, BREACH OF CONTRACT AND NEGLIGENT OR INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS.
9. I understand that if at the end of my participation in the Qualifying Rounds, I am a member of the winning team at the Regional Host Site, subject to the Rules and Regulations, that I and my teammate may be eligible to advance to the National Finals. Costs of travel to and from the National Finals and accommodations while there will be our sole responsibility. I understand that if at the end of my participation in the Golf Challenge I am a member of the winning team at the National Finals, subject to the Rules and Regulations, I and my teammate will be declared the "winner". I understand and agree that any prizes won by me cannot be assigned, transferred, exchanged, or sold, and I may not agree to share, assign, transfer, exchange or sell my prize before it has been awarded to me. I understand and agree that I will be solely responsible for any federal, state, local and foreign tax liabilities resulting from the awarding of any such prizes.
10. I hereby agree that this Release shall be governed, interpreted and construed in accordance with the laws of the State of New York without regard to conflicts of law principles. I further agree that New York City shall be the exclusive forum for the resolution of any dispute arising out of this Release or my participation in the Golf Challenge without regard to venue or jurisdictional rules.
11. Terms capitalized but not defined herein shall have the meanings ascribed to them in the Rules and Regulations, the Entry Form or other applicable document, as the case may be.
12. Should any provision hereof be found invalid, in whole or in part, it shall not affect the validity or enforceability of any other provision hereof or of that provision insofar as it is not invalid or unenforceable.
13. I further represent that I am an amateur player and, if in the Net or Senior Division, I am not an employee, officer, director or agent of ESPN, Inc., I acknowledge that I have read this Release, have the full authority to enter into it, am executing it knowingly, voluntarily, and free from any coercion or duress, and am fully aware of its contents and legal effects. I hereby acknowledge that I have had an opportunity to consult with an attorney prior to signing the Entry Form binding me to this Release. I agree to abide by all of its terms.
